Dear Service Providers,

This communique serves to advise that we will be launching a "Step-Up" incentive.

As we upgrade the Velocity network to 1G capable speeds we want to encourage customers to try faster speeds and experience what it's like to have a super-fast connection.

Incentive Period

Eligible Services
